GENERAL INFORMATION

Directions for Use: Shake the can thoroughly before spraying. Hold can upright and apply from a distance of 15-30 cm (6-12 inches). Ensure adequate ventilation. Do not spray on a naked flame or any incandescent material. Check compatibility with painted or coated surfaces, plastics and rubbers if the product is liable to contact these materials. Do not be mixed with any other lubricant as cross contamination may void the H1 registration. All traces of any previous lubricants should be removed prior to application. The storage temperature should be kept below +50°C, and the storage area should be out of direct sunlight. Shelf life is 3 years from date of manufacture.

All ingredients are FDA listed ingredients under 21 CFR 178.3570. **FOODGUARD HT Chain Spray** is NSF H1 registered and meet the USDA 1998 H1 Guidelines.
